The writing or note indented and made the twenty day of October in the two & forty year of Raigne of Lady Elizabeth by the grace of god of England France and Ireland Quene defender of the faith Between Gregory Cromwell esquire of the one pt and Sir Andrew Noel knight of the other pt wherein are specified in briefly mentioned all such leases and grants wh have been heretofore made & granted by the said Gregory Cromwell or by his late father Henry Lord Cromwell deseased of dyvers messuages & cottages yardland and other things in Langham in the Countye of Rutland and be not expired at the day of the makeinge & instigating of these presents

Imprimis one lease made unto **Robert Skulthorpe** of a messuage a close and one yardland with their appurtances by indenture bearing date 1 October ano Eliz Reg 24th wherein there is not above the terme of three yeares yet to come

Item one lease made to **William Thrasey** [or Thrasty? FS] bearing the date aforesaid first day of October of a messuage Two yardlands and one piece of meadow called Redspire with there appurtances wherein there is not above the term of three yeares yet to come
